Citizens to be Heard Discussion Items by Commissioners Motion to Adjourn MINUTES OF THE REGULAR MEETING OF THE BOARD OF CITY COMMISSIONERS FOR THE CITY OF PORT ST. JOE, FLORIDA, HELD IN THE COMMISSION CHAMBER AT CITY HALL, September 15, 2015, AT 6:00 P.M. The Meeting was held in the Port St. Joe Fire Department Meeting Room due to a request for accessibility from a citizen.

The following were present: Mayor Patterson, Commissioners Ashbrook, Buzzett, McCroan, and Thursbay. City Manager Jim Anderson, City Clerk Charlotte Pierce and Attorney Tom Gibson were also present.

CONSENT AGENDA

Minutes

A Motion was made by Commissioner Thursbay, second by Commissioner Ashbrook, to approve the Minutes of the Regular Meeting and Budget Workshop on September 1, 2015; Joint City / County Workshop on September 2, 2015; Burton and Associates Workshop on September 8, 2015, and the Special Meeting of September 10, 2015. All in favor; Motion carried 5-0.

PORT ST. JOE REDEVELOPMENT ASSOCIATION (PSJRA) - Bill Kennedy

Mr. Kennedy shared that he is working with downtown businesses to make them aware of the Façade Grants that are available through the PSJRA; he is looking at revisions to be made to the downtown map; noted that golf carts would be good for the downtown and waterfront areas; deferred an inquiry from the FL Lighthouse Association to Clerk Pierce, and reminded the PSJRA Board of an onsite meeting at the lighthouse facility at 8:30 A.M., tomorrow.

CITY ATTORNEY - Tom Gibson

Patton Park Plat Approval – The PDRB has reviewed and recommends approval of the plat. Preble-Rish will prepare the final plat for signatures. A Motion was made by Commissioner Ashbrook, seconded by Commissioner Thursbay, to approve the Patton Park Plat. All in favor; Motion carried 5-0.

Ordinance 518 Water Rates: First Reading – A Motion was made by Commissioner Buzzett, second by Commissioner Thursbay, for Ordinance 518 to be read by Title only. All in favor; Motion carried 5-0.

Attorney Gibson read Ordinance 518 by Title only.

Ordinance 519 Sewer Rates: First Reading – A Motion was made by Commissioner McCroan, second by Commissioner Thursbay, for Ordinance 519 to be read by Title only. All in favor; Motion carried 5-0.

Attorney Gibson read Ordinance 519 by Title only.

Resolution 2015-06 Impact Fees – A Motion was made by Commissioner Thursbay, second by Commissioner McCroan, to approve Resolution 2015-06. All in favor; Motion carried 5-0.

Jetty Park Name Change – A Motion was made by Commissioner Thursbay, second by Commissioner Ashbrook, to approve changing the name of Jetty Park to Clifford C. Sims Memorial Park effective September, 2016. All in favor; Motion carried 5-0. The reason for the delay in the changing of the name is because of existing brochures that have just been printed. This will allow for time to use up the brochures and give ample notice of the change for future publications.

CITY MANAGER'S REPORT - Jim Anderson

Old Business

102 Stone Drive: Building Permit – The Stop Work Order (SWO) remains in force, Mr. Mike is looking at other properties; he is in hopes of a resolution so the SWO can be lifted and avoid legal involvement. Mr. Anderson noted that Building Inspector, Bo Creel, will not make any changes until directed by the Commission. The Board directed Mr. Creel to work on a foundation plan with the manufacturer and bring it back to the Board for review.

Northwest Florida Water Management District Grant - The bids are currently \$106,000 over budget and Staff is reviewing options to reduce the cost of the project for the Lime pretreatment and distribution line from Highway 71 to Tenth Street and from Long to Monument Avenue. NWFWMD will have additional funding available October 1 and there is a possibility of additional help with the project.

Highway 98 Golf Cart Crossing: Mayor Patterson – The following individuals spoke in favor of being able to cross Highway 98 in golf carts: Roni Coppock, Guerry Magidson, Phil Earley, Benny Roberts, Ed Creamer, and Boyd Pickett. After discussion and opinions were expressed, Clay Smallwood, III, of PRI suggested that he discuss the possibility of a crossing with DOT, see if it is feasible, and what would be required.

New Business

Fee Waiver Request for the Centennial Building 2/22/16 - 3/31/16 TDC Film Crew – Ms. Jenkins has indicated that the facility is not needed at this time.

Kiosk Signs – The Kiosk signs throughout the City are weathered and in need of replacement. Mr. Anderson has asked Ms. Jenkins if the TDC can help with this.

Cape Sewer Billing – Mr. Anderson has been talking with Jay Rish about options to resolve this issue. Commissioner Buzzett requested this item remain on the Agenda until it is resolved.

Old Ward Ridge City Hall Building: Commissioner Thursbay encouraged the Commissioners to visit the site and consider it as a permanent meeting location for the City.

Flashing Sign on 20th Street: Commissioner Thursbay asked for help in placing a flashing sign near the Faith Christian School. Chief Herring is working with Sheriff Mike Harrison on this and anticipates having it resolved shortly.

Speed Bumps on 6th Street: Commissioner Thursbay noted this is a unique street in that there are 4 homes, 3 parking lots and a high volume of traffic. He asked for the Commissioner's help in resolving the traffic issues on Sixth Street and encouraged them to visit the area.

Delineators on Highway 98: Commissioner Buzzett shared his concerns about the safety issue of drivers crossing the double yellow lines to enter McDonald's and Hungry Howie's. Commissioner Buzzett offered a Motion to install delineators but withdrew the Motion after discussion. John Grantland is to contact Transfield Services about ways to eliminate the safety hazards.

Employee Wellness Program: Commissioner Buzzett has been talking with Dwight Van Lierop, the City's Insurance Agent, and Sara Hines of the Gulf County Health Department on ways to create and encourage an Employee Wellness Program for the City. He will bring their suggestions back to the Commission.

Commercial Utility Rates: Mayor Patterson requested that the Commission look at options to reduce the Commercial II, Commercial II, and Residential rates in the future.

Commercial Trash Pick-up: Mayor Patterson is concerned about the inability to help residents with smaller piles of trash that need to be picked up. Mr. Anderson explained the current process and noted that residents may call for a special pick up.

Public Works - John Grantland

Sick Leave Pool – Mr. Grantland requested permission for employees of the Public Works Department to donate time to a fellow employee who is out of leave time and is facing medical issues. A Motion was made by Commissioner Thursbay, second by Commissioner McCroan, to grant the request. All in favor; Motion carried 5-0.

Mr. Grantland noted that Sapodilla Lane is complete and the light pole at the Tenth Street Park has been replaced.

Surface Water Plant – Larry McClamma

St. Joe Beach Tank – Mr. McClamma advised that the 20 year old glass fused steel storage tank at St. Joe Beach is in need of fabricating work. Between the salt air and Chlorine in the tank, rust is becoming a problem. Commissioner McCroan will look at the tank and this item will be tabled until the tank has been checked.

Wastewater Plant – Lynn Todd shared that the effluent line has been repaired, tested, fired and no leaks were found. The Lagoon looks good, there is no odor or greenery associated with it.

City Engineer - Clay Smallwood, III, did not have anything new to share with the Commission. He anticipates having the Patton Park Plat available by next week.

Code Enforcement

Mr. Burkett's report was reviewed, no action was taken. Mayor Patterson noted the success of getting the vacant lots cleaned up and encouraged citizens to keep their lots clean.

Mr. Anderson noted that the Tourist Corridor Ordinance relative to Overnight Parking becomes effective next week.

Ann White requested that *No Parking* signs be placed at Patton Park as individuals are parking their vehicles in the park.

Police Department - Chief Herring did not have anything to update the Commission on.

Various Commissioners noted the increase in under aged drivers of golf carts in the City and instructed Chief Herring to crack down on this violation. It was noted that the Golf Cart Ordinance requires that a driver be 16 years of age and have a valid Florida Driver's License. He was also asked to monitor the issues on Sixth Street. Chief Herring will pass these requests to the Police Department officers.

City Clerk - Charlotte Pierce did not have anything to report.

Citizens to be Heard

Christy McElroy thanked the Commissioners for cracking down on the under aged drivers of golf carts. She asked for more enforcement on the walking / bike path to keep golf carts off of it; encouraged the Commissioners to do what is in the best interest of our community; resolve the modular home issue; be welcoming to individuals coming to our community, and set goals of what we want our community to look like in the future.

Mayor Patterson reiterated that Garrison, Long and Monument Avenues are only cross over roads for golf carts and are not to be used as driving streets.

Amy Rogers reminded Commissioners of the Fair Housing Act; encouraged residents to treat everyone with respect; requested that tax payer's money not be wasted but work on cleaning up the water and trash areas;

suggested that the Washington Gym be used for Commission meetings, and also noted that the bleachers at Peters Park need to be larger.

Commissioner Thursbay shared that Gulf County Commissioner Sandy Quinn is working on the bleachers issue and encouraged Ms. Rogers to talk with him about this.

Discussion Items by Commissioners

Commissioner Thursbay shared that he had spoken with Mr. Anderson and feels that the City should buy employee's uniform shirts, allow them to launder their own shirts and save a nice sum of money by eliminating the laundry bill. Staff will look at this and bring their suggestions back to the Commissioners.

Commissioner Ashbrook asked if the Port Authority meeting for September had been cancelled. Mr. Gibson responded, "Yes" and noted the October meeting is scheduled for the second Wednesday at Gulf Coast State College.

He also asked if the PDRB is working on an architectural design for the future of Port St. Joe to which Mr. Anderson acknowledged they were.

Commissioner Ashbrook reminded citizens of the Fire Flow Test scheduled for tomorrow.

Commissioner McCroan did not have anything to discuss.

Commissioner Buzzett shared that all of his concerns were addressed in the meeting.

Mayor Patterson asked if Duke Energy had taken care of tree limbs on lines and in the yard in the Allen Memorial Way area. Mr. Anderson noted he has spoken with Duke Energy about this.

A Motion was made by Commissioner McCroan, second by Commissioner Buzzett, to adjourn the Meeting at 7:35 P.M.

The Meeting was held in the Port St. Joe Fire Department Meeting Room due to a request for accessibility from a citizen.

The following were present: Mayor Patterson, Commissioners Ashbrook, Buzzett, and McCroan. City Manager Jim Anderson, City Clerk Charlotte Pierce, Financial Analyst Mike Lacour, and Chief Matt Herring were also present. Attorney Gibson was absent. Commissioner Thursbay was absent due to a medical appointment.

The purpose of the Special Meeting was Ordinance 516-2015 / 2016 Ad Valorem Tax Millage Rate Public Hearing and Second Reading; Ordinance 517-2015 / 2016 Budget Public Hearing and Second Reading; and consideration of Adoption of both Ordinances.

Ordinance 516, Ad Valorem Taxes

Public Hearing: No one from the public addressed the Commission.

A Motion was made by Commissioner McCroan, second by Commissioner Buzzett, to have the Second Reading of Ordinance 516. All in Favor; Motion carried 4-0.

City Manager Jim Anderson read Ordinance 516 in its entirety.

A Motion was made by Commissioner Ashbrook, second by Commissioner McCroan, to adopt Ordinance 516. All in favor; Motion carried 4-0.

The Millage rate will be 3.5914 for Fiscal Year 2015 – 2016. The percentage by which this Millage rate to be levied is more than the rolled-back rate of 3.5213 Mills (computed pursuant to Florida Law) is 1.99%.

Ordinance 517, 2015 - 2016 Budget

Public Hearing: No one from the public addressed the Commission.

A Motion was made by Commissioner Buzzett, second by Commissioner McCroan, to have the Second Reading of Ordinance 517. All in favor; Motion carried 4-0.

City Manager Jim Anderson read Ordinance 517 by Title only.

A Motion was made by Commissioner Buzzett, second by Commissioner Ashbrook, to adopt Ordinance 517. All in favor; Motion carried 4-0.

Mr. Anderson expressed his appreciation to the Commission and Staff for all their hard work on preparing and adopting this year's budget. The Commission also thanked Staff for their diligence in presenting a sound, workable budget for the coming year.

Grievance Committee Membership

A Motion was made by Commissioner McCroan, second by Commissioner Buzzett, to appoint John Ford to replace Mike Lacour on the Grievance Committee. All in favor; Motion carried 4-0. The Hearing will be held on Monday, October 5, 2015, at 1:00 P.M. in the Meeting Room of the Port St. Joe Fire Department Meeting Room.

Lighthouse Moon Light Climb

A Motion was made by Commissioner Buzzett, second by Commissioner Ashbrook, to hold a Full Moon Climb at the Lighthouse on Tuesday, October 27, 2015. All in favor; Motion carried 4-0.

Northwest Florida Water Management District (NWFWMD) Grant Application

Mr. Anderson shared that funds are available to complete the Lime Feed System but the Distribution project is approximately \$32,000 short. NWFWMD has agreed for the City to submit a request for the additional funds in the grant cycle.

To replace the main 10" trunk line from the Surface Water Treatment Plant to the First Street and Long Avenue Intersection, would require approximately \$115,000. A Motion was made by Commissioner Ashbrook, second by Commissioner McCroan, for the City to apply for a grant to fund both projects. All in favor; Motion carried 4-0.

Citizens to be Heard

Christy McElroy shared her concerns about the application of the PACES Foundation for affordable housing. See has spoken with Gulf County Commissioner Sandy Quinn, he has called the Affordable Housing office in Tallahassee and requested that the PACES Application be pulled. Ms. McElroy left information to be copied and distributed to Commissioners.

Charles Gathers addressed the Commissioners about his concerns with the PACES Foundation Project. Mr. Gathers has issues with the information originally provided by PACES and what they are now proposing. He asked that the Commission review all materials before making a decision.

Commissioner Buzzett noted that we have one chance to get this right; questions need to be asked, materials need to be studied, and then come up with a project that we can be proud of.

Commissioner McCroan asked that the project be looked at closely and he feels we can do better than a three story building.

RESOLUTION NO. 2015-07 CITY OF PORT ST. JOE, FLORIDA

WHEREAS, the City of Port St. Joe is a political subdivision of the State of Florida; and

WHEREAS, the City of Port St. Joe is susceptible to a number of natural and man-made hazards that can impact large segments of the population and infrastructures; and

WHEREAS, the Gulf County Comprehensive Emergency Management Plan (CEMP) identifies all known hazards that can impact the City of Port St. Joe and Gulf County; and

WHEREAS, the Gulf County Comprehensive Emergency Management Plan establishes the overarching guidance for Gulf County and the City of Port St. Joe to prepare for, respond to, recover from and mitigate the impacts of such hazards; and

WHEREAS, Chapter 252 Florida Statutes, and Rule 27P-2, Florida Administrative Code establishes the requirement that every County/Municipality have an approved Comprehensive Emergency Management Plan; and

WHEREAS, the Comprehensive Emergency Management Plan supports the management of disasters throughout the entire county; it is

RESOLVED, that the 2015 Gulf County Comprehensive Emergency Management Plan shall govern emergency operations in Gulf County and all its Municipalities and all such operations will be in accordance with the policies stated therein, and

ORDINANCE NO. 514

AN ORDINANCE OF THE CITY OF PORT ST. JOE, FLORIDA AMENDING SECTION 3.01 OF THE LAND DEVELOPMENT REGULATIONS OF THE CITY; PROHIBITING THE OVERNIGHT PARKING OF CERTAIN VEHICLES IN DESIGNATED AREAS OF THE CITY; PROVIDING FOR PENALTIES; PROVIDING FOR SEVERABILITY; PROVIDING FOR REPEAL OF ORDINANCES IN CONFLICT; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Planning and Development Review Board of the City of Port St. Joe (PDRB), pursuant to PDRB responsibilities pursuant to Section 2.11(f) of the Land Development Regulations (LDR's) and after consideration of information presented at advertised public hearing has found that safety and esthetic concerns are impacted by overnight parking of certain vehicles and as such, justify the regulation of parking of certain vehicles in designated areas of the City; and

WHEREAS, the PDRB also finds that the areas designated herein are all located within Tourism Corridors which justify heightened parking restrictions to insure the availability of parking and to promote order and attractiveness within the Tourist Corridor; and

WHEREAS, the PDRB has made recommendation to the City Commission to enact certain changes to the LDR's to enact parking regulations described herein; and

WHEREAS, the City Commission has held public hearings as required by statute and determined, based on PDRB recommendations and information submitted at City Commission hearings that parking regulations set forth herein are a reasonable and least restrictive manner in which to address the concerns raised by the PDRB.

NOW, THEREFORE, be it enacted by the people of the City of Port St. Joe, Florida as follows:

- 1. The City Commission approves and adopts the findings and recommendations of the PDRB.
- 2. Section 3.01 of the Land Development Regulations of the City of Port St. Joe, Florida is hereby amended by the addition of Paragraph (7) which reads as follows:
 - (7) Except as hereinafter provided:
 - (a) No recreational vehicle, camper, boat, jet ski, trailer of any type or any similar item of personal property (collectively "Property"), whether or not it is properly registered with the State of Florida, shall be parked

or stored for a period of more than seven (7) calendar days within the area of the City designated in Exhibit A attached hereto and made a part hereof unless it is stored completely within a building so that it is not visible from a public street or alley.

(b) Penalties for violation of this ordinance shall be as set forth in Section 1-15 or Chapter 2, Article IV, Code of Ordinances, City of Port St. Joe.

3. REPEAL

All ordinances or parts of ordinances in conflict herewith are hereby repealed.

4. SEVERABILITY

The provisions of this Ordinance are hereby declared to be severable. If any provision of this Ordinance, or the application thereof, to any person or circumstance is held to be invalid, such invalidity shall not affect other provisions or applications of this Ordinance that can be given effect without the invalid provision or application.

5. EFFECTIVE DATE

This Ordinance shall become effective 60 days after its adoption by the City Commission.

This Ordinance was adopted in open regular meeting after its second reading this 2/24 day of 4015.





- 11. Unshielded Illumination: Signs that have unshielded illuminating devices or which reflect lighting onto public rights-of-way, thereby creating a potential traffic or pedestrian hazard.
- 12. Moving Signs: Signs that move, revolve, twirl, rotate, flash, including animated signs, multi-prism signs, floodlights and beacon lights, except when required by the Federal Aviation Agency or other governmental agency.
- 13. Obstructions: Signs that obstruct, conceal, hide, or otherwise obscure from view any official traffic, government sign, signal, or device, or presents a potential traffic or pedestrian hazard, including signs which obstruct visibility.
- 14. Three-Dimensional Objects: Three-dimensional objects that are used as signs, carried, waved, or otherwise displayed by persons either on public rights-of-way or in a manner visible from public rights-of-way, intended to draw vehicular and pedestrian attention for a commercial purpose (not intended to limit the display of placards, banners, flags, or other signage by persons participating in demonstrations, political rallies and similar events that have been properly permitted).
- 15. Signs Omitted from the Code: Any sign that is not specifically described or enumerated as permitted within the zoning district classifications in the land development code.
- 16. Flags and Banners as permanent signage.

6.0.4 Enforcement of Prohibited Signs

1. Any sign that is installed, erected, altered, moved or replaced in violation of this Article is prohibited. The enforcement of sign regulations will be performed by the Code Enforcement Inspector (CEI), the City Manager, or his designee. The owner or person or firm maintaining the sign shall, upon notice either written or verbal from the City Manager, CEI, or his designee, shall remove prohibited signs. Any such sign not removed or properly altered within the time period allotted from 15 days of the date of the notice, may be removed by the City and all costs charged to the property owner, agent, or person having beneficial interest in the sign itself.

2. Derelict Signs

Should any sign become insecure or in danger of falling or otherwise unsafe in the opinion of the City Manager or his designee, the owner or person or firm maintaining the sign shall, upon written nor verbal notice from said enforcement officer, forthwith in the case of immediate danger and in any case within (48 hours), remove such sign or secure it in a manner approved by the enforcement officer. Any such sign not removed or properly secured within the time period allotted from the notice, may be removed by the City and all costs charged to the property owner, agent, or person having beneficial interest in the sign itself.

3. Temporary Signs

Pennants, streamers, banners, wind-blown devices, real estate signs, real estate directional signs, semi-public-use directional signs, signs in the right-of-way, and construction signs that do not conform to the provisions of this Article upon its adoption or amendment shall be removed within ten (10) days.

4. Nonconforming Signs and a new business

A nonconforming freestanding or building sign shall not be reused for a new business or establishment and shall be removed within thirty (30) days after the business or establishment to which the sign initially pertained ceases to operate at the subject location. This includes the replacement of a sign face module for a new business on a sign or sign structure that exceeds the maximum area or height requirements established by this Article.

5. Change or Removal of Discontinued Signs

When a property owner has a lawful and conforming freestanding or building sign that no longer is used by a business or establishment, and the owner desires to retain said sign, this section shall apply in order to retain said freestanding sign as a lawful sign. If the discontinued freestanding sign or building sign contains a sign face that is in the form of a removable sign face module, the removable sign face module containing advertising shall be removed and replace with a panel of like or similar appearance without advertising until another use is lawfully established. If a discontinued freestanding sign or building sign contains a sign copy area that is not removable, the said sign shall be removed or the copy area shall be painted over to conceal the advertising.

6.0.5 Prohibited Sign Locations

- 1. No sign shall be placed or located in a manner inconsistent with this Section.
- 2. Location in right-of-way prohibited. No part of any sign shall be located in, over, or project into a public right-of-way except for awning signs, canopy signs, or projecting signs in the commercial district.
- 3. Obstructions of buildings and roadways prohibited. No sign shall be erected, located, or maintained in such a manner as to interfere with safe and free ingress and egress of any door, emergency exit, driveway, street, or roadway.
- 4. Obstruction of utilities prohibited. No sign shall interfere with such utilities as water mains and hydrants, sanitary sewerage, gas, electricity, and communications equipment or lines, and shall not interfere with natural or man-made storm-water drainage facilities.
- 5. Obstructions of views and confusion with traffic controls. No sign shall be erected or maintained where, by reason of its position, wording, illumination, size, shape or color, it may obstruct the view of oncoming vehicles or impair, obscure, interfere with the view of, or be confused with any authorized traffic control sign, signal, or device. No sign shall contain or be in imitation of an official governmental traffic control sign, signal, or emergency vehicle device.
