The following were present: Mayor Patterson, Commissioners Ashbrook, Buzzett, Lowry, and Thursbay. City Manager Jim Anderson, City Clerk Charlotte Pierce, and Attorney Tom Gibson were also present.

CONSENT AGENDA

Minutes

A Motion was made by Commissioner Thursbay, second by Commissioner Ashbrook, to approve the Minutes of the Regular Meeting on June 21, 2016. Motion carried 5-0.

Port St. Joe Redevelopment Association (PSJRA) - Bill Kennedy was not at the meeting and Commissioner Buzzett shared there was nothing new to report other than the PSJRA is working on their budget.

CITY ATTORNEY - Tom Gibson

Ordinance 525 Alcohol Sale Within 100' of a Church or School – Second Reading and Consideration of Adoption: A Motion was made by Commissioner Thursbay, second by Commissioner Buzzett, to read Ordinance 525 by Title. All in favor; Motion carried 5-0. Attorney Gibson read Ordinance 525 by Title.

A Motion was made by Commissioner Ashbrook, second by Commissioner Buzzett, to adopt Ordinance 525. All in favor; Motion carried 5-0.

CITY MANAGER'S REPORT - Jim Anderson

Digital Sign – Mayor Patterson scheduled a Workshop for Monday, July 11, 2016, at 5:30 P.M. to talk with the sign company.

Roni Coppock, Executive Director of the Gulf County Chamber of Commerce, discussed the Sign Survey results that she had received through the Chamber.

Propane Gas Trucks – Mayor Paterson asked the Commissioners to be thinking about the possibility of trying a Propane Gas Truck for several departments in the new fiscal year. He requested that this issue remain on the Agenda.

Waste Water Lagoon Study - Letter from Eastern Shipbuilding: No action was taken.

New Business

FRDAP Committee Membership – A Motion was made by Commissioner Buzzett, second by Commissioner Ashbrook, to appoint Brian Marshall and Commissioner Thursbay to the FRDAP Committee. All in favor; Motion carried 5-0.

City Uniforms - This item was Tabled to allow for more research.

Fee Waiver Requests- New Bethel African Methodist Episcopal Church: Ray Bailey: NPSJ-PAC:

Chester Davis, representing the NPSJ-PAC, shared that they are beginning a program to buy tables and chairs that can be placed in the gym for the public to use.

Audit Report Update – Mr. Anderson shared that the audit is complete and will schedule a date to review it with Auditor Ben Vance.

A Motion was made by Commissioner Buzzett, second by Commissioner Thursbay, to declare the items Surplus Property and hold a Sealed Bid Auction. All in favor; Motion carried 5-0.

Surface Water Plant - Larry McClamma did not have anything to share with the Commission.

Wastewater Plant – Kevin Pettis noted that everything is working well, the Algae is not matting, and he feels the Sonic Disrupters are doing their job.

City Engineer - Clay Smallwood, Ill, was not present due to the birth of his son. Mr. Anderson and Mr. Grantland addressed the following issues.

Golf Cart Crossing Update – The application has been submitted and the requirements will be forthcoming.

NWFWMD Grant Application Options – Staff recommendation is to submit an application for the water line replacement down town with the work being done by the City. This should be ready for approval at the next meeting. This will be Phase III and should be less than \$100,000.

Project Updates -

Highways 71 & 98 Waterline Replacement - Mobilization will start next week on the project.

Garrison Avenue Paving – This project will be done with an FDOT SCOP Grant and the plans are almost ready.

Road Bond Money – Long Avenue Options: The County has allotted \$1,050,000 for the City which is short of the expected costs for Water, Sewer and Road replacement. Additional reviews will be done before the next meeting on the possibility of funding.

6th and 7th Streets Drainage - The City Engineer is working on the plans.

Frank Pate Park Boat Ramp Improvements – The funds have been secured, engineering is working on the project, and it is anticipated bids will be let by summer's end.

Keepers Quarters – GAC is currently securing the pilings. Commissioner Thursbay commend GAC for making a wrong right.

Code Enforcement – Mayor Patterson noted that there was an increase in Sign Violations and there are two issues to be heard by Special Master.

Commissioner Thursbay requested that the record reflect that political signs are a pain, they were allowed to remain through the City's election, and he has a problem with requiring that signs be removed if they are not a safety issue.

Police Department – Chief Herring noted that "Touch a Truck" was a great success, he thanked the Star for their nice article and coverage of the event, and noted the previous weekend was quiet.

City Clerk - Charlotte Pierce

Mrs. Pierce did not have anything to share.

Citizens to be Heard -

Roni Coppock, Executive Director of the Gulf County Chamber of Commerce, shared that she had received compliments on the 4th of July festivities and thought everyone did a great job.

Mrs. Coppock noted that the responses to the Sign Survey were overwhelming, 72 responses in 5 days, and that people liked being asked their opinion. Results of the survey have been provided to the Commissioners.

The offer to be a Courtesy Member of the Chamber of Commerce was extended by Mrs. Coppock to the Commission.

Chester Davis, President of the North Port St. Joe Project Area Committee (NPSJPAC), thanked the Commissioners for the use of the Washington Gym on July 2, 2016, and shared his concerns that so few City people were at the gathering. He noted that their group would be working to provide supplies for the gym that can be used by the public.

Mr. Davis invited the Commission to a July 16, 2016, NPSJPAC Workshop that will begin at noon.

Letha Mathews asked for the current status of the Housing Project. Mayor Patterson stated he would call Rick Haymond and Commissioner Thursbay shared that he had sent Mr. Haymond an email.

Discussion Items by Commissioners

Commissioner Buzzett discussed the possibility of improving the City's reserves by selling unused property. He noted that if the properties on Water Plant Road, the area near Sunset Coastal Grill, and at the intersection of Woodward Avenue and Seventh Street were not going to be used, the Commission should possibly look at selling them. Inquiries have been received on the properties and this could help both the City and residents.

Commissioner Lowry noted the letter from Eastern Shipbuilding was a good starting point and asked that Mr. Anderson and Attorney Gibson review the letter to keep the ball rolling.

Mr. Lowry stated he was happy to be serving and thanked the public for their support that made it possible for him to serve.

Commissioner Ashbrook suggested that a committee be appointed to direct 4th of July activities for 2017. Residents have shared their concerns with him that we are missing a community wide event prior to the fireworks and he would like to see if a committee could be tasked with the possibility of providing events.

Commissioner Thursbay thanked everyone for a good 4th of July. He also questioned why County Commission Meeting are on the FairPoint and Mediacom Channels but not the City meetings.

Mayor Patterson noted that the Food Pantry needs additional space and he will get with Johanna White to get more specific information on the needs.

A Motion was made by Commissioner Thursbay, second by Commissioner Buzzett, to adjourn the Meeting at 7:10 P.M.

MINUTES OF THE SPECIAL MEETING OF THE BOARD OF CITY COMMISSIONERS FOR THE CITY OF PORT ST. JOE, FLORIDA, HELD AT 2775 Garrison Avenue, July 13, 2016, at 12 Noon.

The following were present: Mayor Patterson, Commissioners Ashbrook and Thursbay. City Manager Jim Anderson, City Clerk Charlotte Pierce, and Attorney Tom Gibson were also present. Commissioners Buzzett and Thursbay were absent.

The purpose of the meeting was to discuss cleanup of the Wastewater Lagoon by Alternative Green Today, LLC. Bob Long, Mason McLemore, and Jon-aric Long, representing Alternative Green Today, LLC, were present to discuss their process and provide information on it.

There will not be a cash outlay to the City for Alternative Green Today, LLC, to test and clean the lagoon. If the process is successful, a letter will be requested from the City validating their success and they would like the City to consider a contract to provide their product to keep the lagoon clean.

Their process consists of introducing enzymes into the lagoon which will dissolve solids and eliminates Algae. This eliminates the lagoon having to be dredged, provides a reduction in chemical costs, electricity, and odor.

Alternative Green Today, LLC, has done sonar images of the lagoon and found that the sludge varies from 5' to 13' depths. They will treat the lagoon with their product, add additional product in 60 - 90 days and once the lagoon is stabilized, City Staff will be able to administer the product locally.

A Motion was made by Commissioner Ashbrook, second by Commissioner Lowry to allow Alternative Green Today, LLC to proceed with attempt to clean the lagoon with their organic product. All in favor; Motion carried 3-0.

Mayor Patterson,

In preparation for the meeting scheduled for the 19th, I have prepared the attached letter to DEO. I am support Clay re-issued the readiness to proceed letter that was supplied for the prior grant cycle with an updated date assure me that the costs would not have changed significantly in construction materials and that the prior year estimates were good. I reviewed his letter for content and all his statements aligned with the required statement rule section I had transmitted to him. Neither of us caught the new requirement that the letter needed to addressed to the "chief elected official."

DEO has elected to remove all 100 points from our score for this technicality. I am proposing that the attached revised as you or the city manager or city attorney may see fit, be submitted immediately after a vote of conse

the full seated board on the 19th. It is common for the staff at CDBG to tweak scores based on math errors, unsubstantiated statements, or other technicalities. The loss of the full 100 points for this technicality, I find exharsh and this proposed letter affirms that. Feel free to add any sense of outrage you may want to express.

Old wording:

Readiness to Proceed Score

"Readiness to proceed" may be claimed if biddable construction plans and specifications for all "addressed need" CDBG activities are coprior to application deadline and have been submitted to any applicable permitting agency or agencies (other than the applying local government). Include in Appendix F a letter from the engineer who prepared the plans and specifications that they have been submitted applicable permitting agency or that no permits are required for the project except from the applying local government. If permits are from an agency other than the local government, include documentation that that the permit applications have been submitted, including the page(s) reflecting the permitting agency name and project description and third-party proof of mailing, such as certified mail recogniting agencies.

Also, submit a signed and sealed copy of the completed construction plans and specifications.

New wording:

Appendix G:Readiness to Proceed Documentation

All required Readiness to Proceed documentation must be submitted with the application or the applicant cannot claim the 100 points. The required documentation includes biddable construction plans and specifications, sealed by an engineer or architect, for all "addressed need" activities in the application that require plans and specifications. To claim the points, the application must also include a letter from the engineer or architect who prepared the plans certifying that the plans are complete and ready for bid and that all infrastructure permits have been applied for except for those would be granted by the applicant agency.

The required documents include the following:

- A letter from the engineer or architect who prepared the construction plans and specifications to the chief elected official of the applicant certifying the following:
 - that the sealed and dated plans and specifications are complete,
 - that the bid documentation, including the plans and specifications, provided with the application contains all of the information that a contribution would need to bid on the project, except for the Davis-Bacon wage decision(s) and the CDGB Supplemental Conditions, and
 - that applications have been submitted for all permits that are required to begin construction on the infrastructure activities included in the
 application. (If the only permitting agency is the applicant local government, the engineer shall certify that the applicant is the only agency
 from which a permit is required. If no permits are required for the project, the engineer shall certify to that effect.)
- A signed and sealed copy of the plans and specifications, plus all necessary bid documents, except for the Davis-Bacon wage decision(s) and ti CDBG Supplemental Conditions;
- Documentation that all required infrastructure permit applications were submitted to the appropriate agency(ies). (Receipts from UPS or the Postal Service, email or letter from permitting agency(ies) saying that the permit applications had been received.)

Re: Port St. Joe CDBG Application

Mr. Doherty;

The City of Port St. Joe, by this letter, formally protests the imposition of a one hundred point penalty in your department's review of our most recent application. We were made aware recently that our application was not to be offered funding in the FY 2015 cycle. We understand and note the discrepancy in the addressing of the Readiness to Proceed letter. We understand that the discrepancy might cause the loss of some scoring. However, we strongly object to the loss of the entire 100 points for this minor technicality, when in point of fact, the letter itself attests to our readiness to proceed.

This letter is backed up by plans and specifications that have been in hand and ready to advertise since the prior cycle's application was upheld by the local newspaper's failure to advertise our second public hearing. That mistake was unfortunate and we understand the legal implications of failing to advertise. The loss of all one hundred points awarded for readiness to proceed status we believe is an egregious penalty applied completely out of scale with the scale of the oversight error. We understand that self scores are often modified for minor math errors, failure to provide certain verifications, etc. and these corrections are commonplace in adjusting application scoring with your office evaluations.

For instance, placing the CATF hearing in the wrong sequence relative to the required public hearings, or failing to have a majority of low to moderate income citizens on the CATF might cause an application to lose five or ten points. Failing to provide an exhibit justifying a consent order might cause the loss of twenty points. Losing ALL one hundred points for the misaddressing of the readiness to proceed letter is, we feel a crippling blow to a community that has been suffering for years from barely palatable water that is discolored, malodorous, stains laundry and even porcelain fixtures.

We understand that the wording of the readiness to proceed section in the application documents is new this year. Our application this year is essentially an update and re-application of the documents developed in full for the prior cycle. The updated letter, addressed as it was to our region's grant manager at DEO, would have sufficed in the prior cycle.

While we concur that the mistake in addressing was made, we formally protest the downward adjustment of the full one hundred points for that error. It seems unjustifiably harsh considering

that the content of the letter itself provides all statements required in your revised application guidelines.








13 x 36 Trunk Mounted Fuel Tank - 14.5 USG
