Financial Update - Mike Lacour

Mr. Lacour provided Financial Updates in the Agenda. Income will be approximately \$24,191 from Ad Valorem Taxes (County \$15,830) and City (\$8,361). Total Revenue for the PSJRA is \$60,086 with expenses of \$3,550 for Accounting and Auditing, \$6,069 for Comprehensive Liability, and \$695 Dues and Subscriptions leaving a Total Net Income of \$13,882. There is \$3,353.19 in a Centennial Bank Money Market Account and \$35,890.53 in the Operating Account at Centennial Bank.

Consultations Services Proposal

Ed Johnson joined the meeting by telephone. Mr. Johnson represents Cardno and has offered to work with the PSJRA. A Motion was made by Rex Buzzett, second by Brett Lowry, to approved the Proposed Task Order from Cardno in the amount of \$9,750 to complete the annual report and advise the Board of compliance.
